ADMINISTRATIVE ORDER TO ASSIGN THE FAMILY COURT DIVISION 13 (FC13)  
DOCKET TO JUDGE DUNNE, THE FAMILY COURT DIVISION 15 (FC15) TO JUDGE  
HARDIN-TAMMONS AND THE FAMILY COURT DIVISION 17 (FC17) TO JUDGE  
GREEN AND TO REASSIGN CASES

WHEREAS, the Family Court of St. Louis County was created by Sections 487.010 through 487.190 of the Revised Statutes of Missouri; and

WHEREAS, the Honorable Margaret Donnelly has been appointed Administrative Judge of the Family Court of St. Louis County pursuant to Section 487.010.3 RSMo.;

WHEREAS, certain changes have been made in the assignments of the Judges in the Family Court of St. Louis County; and

WHEREAS, the Honorable Jason D. Dodson (FC13) and the Honorable Mondonna L. Ghasedi (FC17) have been reassigned to other judicial duties within the Circuit Court of St. Louis County, Missouri, effective January 1, 2019; and

WHEREAS, the Honorable Ellen Wyatt Dunne, the Honorable Renee Hardin-Tammons, and the Honorable Joseph L. Green have been appointed to serve as Judges of the Family Court effective January 1, 2019.

NOW THEREFORE IT IS ORDERED that effective January 1, 2019, the Honorable Ellen Wyatt Dunne be assigned to the Family Court Division 13 (FC13) docket and that all cases on the FC13 docket that are not under submission and all cases assigned to the FC13 docket thereafter, with the exception of the IV-D paternity cases, be assigned to the Honorable Ellen Wyatt Dunne for hearing and determination; and

IT IS FURTHER ORDERED that effective January 1, 2019, the Honorable Renee Hardin-Tammons be assigned to the Family Court Division 15 (FC15) docket for hearing and determination and assigned cases from other divisions to give the division a full docket of cases; and

IT IS FURTHER ORDERED that effective January 1, 2019, the Honorable Renee Hardin-Tammons be assigned to hear a DV order of protection docket currently assigned to the Honorable Mondonna Ghasedi (FC17) docket; and

IT IS FURTHER ORDERED that effective January 1, 2019, the Honorable Joseph L. Green be assigned to the Family Court Division 17 (FC17) docket and that all cases on the docket that are not then under submission and all cases assigned to the FC17 docket thereafter; with the exception of the order of protection cases currently assigned to the FC17 docket, be assigned to the Honorable Joseph L. Green for hearing and determination; and

IT IS FURTHER ORDERED that effective January 1, 2019, the Honorable Joseph L. Green be assigned to hear a non-DV order of protection docket, currently assigned to the Honorable Bruce Hilton (FC6) docket; and

IT IS FURTHER ORDERED that for purposes of Missouri Supreme Court Rule 51.05, the new assigned Judge shall be designated as trial Judge upon the effective date of the assignments hereunder; and

IT IS FURTHER ORDERED that the Circuit Clerk provide notice of these assignments by causing this order to be published as soon as practicable in *The St. Louis Countian*, by posting a copy of this order in a conspicuous place in the Office of

the Circuit Clerk, and by making copies of this order available for distribution from the Office of the Circuit Clerk.
