My experience goes back to the time when I received my J.D. degree from Washington Univ. in St. Louis in 1946. After a brief time practicing law I began teaching full time at St. Louis Univ. School of Law. I taught many judicial subjects, especially civil procedure until 1971, when I was appointed to the Missouri Court of Appeals Eastern District. I served full time as Chief Judge and then was appointed to the Supreme Court of Missouri. In addition to serving on the courts I worked closely with the Missouri General Assembly and was the principal draftsman of the present judicial article in the Missouri Constitution, the Public Defender Bill, the drug bill, the present Criminal Code among others. I also was appointed as an Admin. Law Judge in the Federal System handling cases under the Social Security Act, in addition to continuing to teach seminars at SLU part-time. In Dec., 2007 I retired and wish to become a mediator. I have a J.D. degree from Wash. U., a B.S. degree from Southern U. and LL.M. + S.S.D. degrees from Michigan University.
