

In re: ST. LOUIS COUNTY CIRCUIT COURT

SECOND AMENDED ADMINISTRATIVE ORDER

In order to address the increased needs of the associate criminal dockets, this court hereby adds a third associate criminal division. Accordingly, the Honorable Nicole S. Medler, Division 37, shall be assigned to hear and determine the Associate Civil Trial De Novo Landlord Tenant dockets, the Small Claims dockets and the Judicial Monitoring Compliance dockets. The Honorable Heather R. Cunningham, Division 33, shall be assigned to hear and determine the DOR re-hearings and the Small Claims Trial De Novo dockets. The Honorable Heather R. Cunningham, Division 33, shall co-sign the Judgments entered by the Honorable Chastidy Dillon-Amelung, Division 46 and the Honorable Peggy McCartney, Division 47. The Honorable Virginia W. Lay, Division 41, shall be assigned to hear and determine the Small claims Trial De Novo dockets, the Expungement dockets and the Judicial Monitoring DV Contempt dockets.
